If you could have someone of some knowledge and understanding (related to DOE and/or DOT) contact me at your/their convenience, I think it may be of great benefit to both our national security and our nation's ability to deal with terrorist threats and national disasters of the scale of the World Trade Center.

I will be pleased to discuss the general aspects of the situation and information with an appropriate individual, and make the arrangements for that person or persons to meet with my client to provide any necessary details.
