
14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)

The purpose of this modification is to: 1) change the Contracting Officer's Representative of the purchase order from Susan Cusseaux to Johnathan Downey; 2) add FAR Clause 52.217-8 Option to Extend Services (NOV 1999); 3) extend the period of performance by six (6) months, thereby changing the period of performance end date from June 24, 2015 to December 24, 2015; and 4) increase the ceiling and obligation amount by \$23,380.50, thereby increasing the ceiling and obligated amount from \$122,877.00 to \$146,257.50.

Accordingly, the following changes are hereby made:

1. FAR Clause 52.217-8 Option to Extend Services (NOV 1999) is added to the purchase order in its entirety:

"The Government may require continued performance of any services within the limits and at the rates specified in the contract. These rates may be adjusted only as a result of revisions to prevailing labor rates provided by the Secretary of Labor. The option provision may be exercised more than once, but the total extension of performance hereunder shall not exceed 6 months. The Contracting Officer may exercise the option by written notice to the Contractor within 30 days."

2. Section A.2 CONTRACTING OFFICER'S REPRESENTATIVE, paragraph (a) is deleted in its entirety and replaced with the following:

3. Section A.4 CONSIDERATION AND OBLIGATION--FIRM FIXED PRICE (JUN 1998), the first sentence in paragraph (b) is replaced with the following:

"(b) The amount presently obligated with respect to this contract is \$146,257.50."

All other terms and conditions of the purchase order remain unchanged.
