Dear Mr. Luongo:

On July 24, 2015, two inspectors from the U.S. Nuclear Regulatory Commission (NRC) conducted a routine inspection at your campus in Rochester, Michigan, with continued in-office review through July 31, 2015. The purpose of the inspection was to review activities performed under your NRC license to ensure that activities were being performed in accordance with NRC requirements. The in-office review included an evaluation of additional information not available at the time of the inspection. Mr. Ryan Craffey and Mr. Navid Tehrani of my staff conducted a preliminary exit meeting with you, Dr. Michael Sevilla, and Dr. Arik Dvir on July 24, 2015. Mr. Craffey conducted a final exit meeting with you by telephone on July 31, 2015 to discuss the inspection findings.

During this inspection, the NRC staff examined activities conducted under your license related to public health and safety. Additionally, the staff examined your compliance with the Commission's rules and regulations as well as the conditions of your license. Within these areas, the inspection consisted of selected examination of procedures and representative records, observations of activities, and interviews with personnel.

Based on the results of this inspection, the NRC has determined that violations of NRC requirements occurred. The violations were evaluated in accordance with the NRC Enforcement Policy. The current Enforcement Policy is included on the NRC's website at <http://www.nrc.gov/about-nrc/regulatory/enforcement/enforce-pol.html>. The violations are of a security-relate nature. Details of the violations are available in the enclosed, non-public Security Addendum (Enclosure 2). The violations are cited in the enclosed Notice of Violation (Notice) (Enclosure 1). The NRC is citing the violations in the enclosed Notice because the inspector identified the violations.
