Discussion: A call was placed to Nuclear Medicine Supervisor at Gifford Medical Center. Gifford Medical Center request dated 06/08/2015, requested that Alan Ericksen, M.D. be authorized for 10 CFR 35.100; 35.200; and 35.500. His ABR certificate was dated 11/09/92. That certificate is not listed as recognized on the NRC website. I requested that they complete a 313 (AUD) following the training and experience pathway and a copy of an NRC license that Dr. Ericksen was listed on (it is >7 yrs ago) and training and experience that covers the last 7 years. They said that they would obtain and forward that information. Also in their letter dated 06/08/2015, they requested a change in their radiation safety officer to Jeffrey Bath, M.D. They want to continue that request now, and will submit new request for Dr. Ericksen as an AU once the additional information is available
