This letter refers to your license amendment request dated June 8, 2015. In your letter you requested to change your Radiation Safety Officer to Jeffrey Bath, M.D., and add Alan Ericksen, M.D. as an authorized user on your license. You further requested to have Scott D. Smith, M.D. removed from your license. On August 5, 2015, I spoke with the Nuclear Medicine Supervisor and requested additional information we need to list Dr. Ericksen as an authorized user on your NRC License. It is our understanding that you may need time to submit the additional information. When the information is submitted to us, we will amend the license to include Dr. Ericksen. Enclosed with this letter is the amended license authorizing Dr. Bath as Radiation Safety Officer.

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region I Office, Licensing Assistance Team, (610) 337-5239, so that we can provide appropriate corrections and answers.

An environmental assessment for this action is not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
