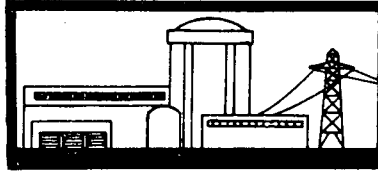

The purpose of this revision is to update the Oconee plant-specific appendix, i.e., Appendix J, to remove BWNT proprietary data. Specifically, Appendix J of Revision 0 contains a proprietary copy of the Generic Component Summary for the GLRP Program (51-1224979-01). BWNT has since released a non proprietary version of the Generic Component Summary for the GLRP Program, i.e., BWNT document 51-1224979-04.

Duke Power revised their plant-specific report by replacing the proprietary Component Summary document with the non proprietary version. The revision did not change any of the ONS plant-specific results. The pages that follow include the revisions incorporated in the front matter and Section 6.0 of the ONS plant-specific document; these pages supersede those presented in Appendix J of BWNT document 47-1228802-00.
