January 19, 1995 Meeting Minutes for the Proposed  
Modification on the Oconee Emergency Power System

In the letter dated January 26, 1995, a summary of the subject meeting was provided. Several statements made by Duke during the meeting are listed in this letter. Two of these statements require additional clarification in order to ensure that the appropriate interpretation is achieved.

The first statement pertains to the fact that the switchyard yellow bus is part of the onsite power system at all times. This should be changed to indicate that the switchyard yellow bus is part of the onsite and offsite power systems. Since the yellow bus is part of the switchyard, it is included in the offsite power system. In addition to being part of the switchyard, the yellow bus is part of the overhead emergency power path following switchyard isolation.

The second statement is that any single failure was assumed to occur simultaneously with the initiating event. This should be changed to indicate that any single failure was assumed to occur immediately upon demand. Therefore, a failure was assumed to occur when the equipment was called upon to perform its safety function. This failure could be simultaneous to the initiating event or at some time during the mitigation of the event.
