Keowee Reliability Analysis

In a letter dated November 10, 1993, Duke Power indicated that a detailed reliability analysis of Keowee would be performed using PRA techniques. This analysis was intended to verify the current Keowee reliability, which was based on actual Keowee normal start history, with a detailed analytical model.

On May 5, 1994, Duke Power met with the NRC to discuss the objectives of the analysis, project scope, project team organization, task list, and schedule. The schedule included periodic meetings with the NRC to provide a status update on the project. These meetings were held on July 12, 1994 and October 12, 1994. Upon completion of the draft analysis in December 1994, a copy of the draft analysis was provided to the NRC for review. The final analysis (attached) incorporates the comments from the draft analysis review, as appropriate.
