In February, 1994, B&W Nuclear Technologies (now Framatome Technologies, Inc.) submitted topical report BAW-10192, "BWNT Loss-of-Coolant Accident Evaluation Model for Once-Through Steam Generators" for review and approval by the NRC. It is Duke Power Company's understanding that the review has neared completion, but the Topical has not yet been approved.

The purpose of this letter is to request that approval of this Topical Report be completed as soon as practicable; Duke intends to use the methodology of BAW-10192 to support the operation of Oconee Nuclear Station, Unit 1 Cycle 18, which is scheduled to begin in August, 1997.
