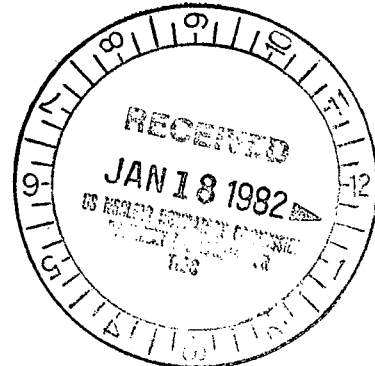


Dear Sir:

By letter dated July 14, 1977, the NRC staff provided an exemption to 10 CFR 50, Appendix H for a period of five years as well as issuing Amendments 44, 44, and 41 to the Oconee Facility Operating License. The staff letter stated that if an extension of the exemption beyond the initial five year term were desired, an application should be submitted no later than six months prior to expiration of the exemption providing a justification that is based on operating experience.

Accordingly, inasmuch as the current exemption expires July 14, 1982, please find attached technical justification for extension of the exemption.

This submittal is considered to be a continuation of an existing licensing action. As such, no license fees are included.
