

Dear Mr. Denton:

In my letter of December 2, 1977 we requested deletion of Appendix B to the Oconee Nuclear Station Technical Specifications which deals with Non-Radiological Environmental Technical Specifications. Your letter of March 2, 1979 transmitting Amendments 69/69/66 to License Numbers DPR-38, DPR-47, and DPR-55 granted, partially, this request by deleting the Environmental Monitoring Program. As discussed in the Environmental Impact Appraisal, this was granted because the program had been completed and the effects on the environment had been adequately quantified. Duke Power Company considers the actions taken to have satisfied the December 2, 1977 request.
