
Dear Sir:

Pursuant to 10CFR 50, §50.90, the attached proposed amendment to the Oconee Nuclear Station Facility Operating License and revision to the Technical Specifications is submitted. This proposed change, which supplements my previous submittal dated October 24, 1980, revised parts of Specification 3.6, Reactor Building and Specification 4.4.1, Containment Leakage Tests to reflect the requirements of 10CFR 50, Appendix J. Certain parts of this submittal have been revised to correctly reflect the actual plant design and to correct certain administrative errors. It is resubmitted in its entirety to facilitate review.

On October 22, 1980, a final rule regarding Type B tests of containment air locks became effective. Duke has been reviewing this change and, upon completion of the review, will provide a submittal addressing containment air lock testing at Oconee.

Inasmuch as this request supplements an earlier request on this subject, it has been determined that no license fees are required.
