Gentlemen:

The purpose of this letter is to document an interim engineering evaluation of the NDE results obtained during the CRDM Nozzle inspection performed at Oconee Unit 2. Based on the attached interim engineering evaluation, it has been determined that the indications detected are acceptable based on the NRC-approved acceptance criteria developed for CRDM nozzle flaws.

Pursuant to the recommendations of Section 5.0 of the attached interim engineering evaluation, Duke Power will perform an NDE inspection of CRDM nozzle # 23 during the next Oconee Unit 2 refueling outage scheduled for April 1996. The need to perform additional inspections on nozzle # 63 will be evaluated prior to the next Oconee Unit 2 refueling outage.
