In Duke Power's letter of January 12, 1993 to the NRC, Duke modified it's commitment to install instrumentation providing positive indication of the functioning of the subject system. The modification involved up grading the power supplies and position indication for valves 2 & 3LP-3 to safety grade. The NRC reviewed this change and found it to be acceptable as documented in it's March 25, 1993 letter to Duke Power.

This letter is to inform the NRC that up grading of the power supply and position indication for valve 2LP-3 to safety grade was implemented during our recent Unit 2 EOC13 refueling outage.
