Joyce,

Thank you for getting back in touch with us and accepting our invitation to participate in the field survey. We understand that you were interested in changing the field survey date to June to avoid a scheduling conflict for one of your survey team members. Unfortunately, we will not be able to accommodate your request to conduct the survey in June as opposed to the April date for the following reasons:

- 1) We have 10 other tribes who've agreed to participate according to the April schedule and changing the schedule at this point would disrupt these plans for many other people.
- 2) We selected the April to May survey schedule to take advantage of optimal field conditions for this type of surface survey. Rescheduling for June once vegetation has emerged would mean doing the work under more difficult conditions with perhaps less than optimal results.

For these two reasons, we would like to keep the field dates in April as originally intended. Please let us know if there is any other way we can be of assistance.
