On Wednesday, August 26, 2015, members of the U.S. Nuclear Regulatory Commission (NRC) staff held a Category 3 public meeting via teleconference. The purpose of the call was to describe the ways that members of the public may provide comments on the NRC staff's draft supplement to the U.S. Department of Energy's environmental impact statement for the proposed high-level waste repository at Yucca Mountain, Nevada. Participants in the call were provided an opportunity to ask questions about the public meetings and comment submittal process.

Approximately 43 people attended the teleconference. Meeting attendees included members of the public, members of federal, state and local government organizations, and members of industry and public advocacy groups. A list of meeting attendees is attached to this summary.

The NRC staff began the teleconference by providing attendees with general historical background concerning the Yucca Mountain repository licensing process. The NRC staff then gave a brief summary of the draft supplement and provided information about how to comment on the supplement at public meetings, by mail, or electronically through the regulations.gov website.

Questions and concerns raised during the public comment portion of the meeting included: requests to extend the public comment period and hold additional public meetings; requests to provide information to grassroots organizations; requests to post documents on the NRC's website; concerns about the *Federal Register* notice; and concerns about the ease of use of the regulations.gov website.
