In the Reference 1 letter, Exelon Generation submitted the License Renewal Application (LRA) for the LaSalle County Station, Units 1 and 2 (LSCS). In the Reference 2 letter, the NRC requested additional information to support the Staff's review of the LSCS Applicant's Environmental Report (Appendix E to the LRA). In the Reference 3 letter (ML15195A351), Exelon Generation provided responses to each of the NRC Staff's questions in the Reference 2 letter. Partial responses were provided for Environmental Requests for Additional Information (RAIs) # AQ-04 and # GW-01 because in each case, additional time was needed to make a requested report available.

May 2011 LSCS Report," NRC Staff explained that the report requested by Environmental RAI # GW-01 will not be needed. Accordingly, Exelon Generation understands that the response to Environmental RAI # GW-01 is complete without submittal of the requested report.
