The purpose of this modification is to:

1) Exercise option year 1, thereby extending the period of performance to February 20, 2016, increasing the ceiling of line item 00001 by \$71,348.28 from \$100,800.00 to \$172,148.28, and increasing the ceiling of line item 00002 by \$65,874.69 from \$36,422.97 to \$102,297.66;

2) Increase the funding of line item 00002 by \$8,000.00 from \$8,200.00 to \$16,200.00.

These actions result in an increase to the entire order ceiling of \$137,222.97, from \$137,222.97 to \$274,445.94, and an increase to the entire order obligated amount of Continued ...
