

Dear Sir:

By letter dated May 30, 1986 the NRC staff requested additional information to complete their review of the capability of the Oconee EFW system to withstand tornado generated missiles, item II.E.1.1 of NUREG-0737. A response was requested within 30 days of the date of the referenced letter.

A review of the requested information indicates that a significant analytical effort will be required in order to provide the requested information. Duke Power Company anticipates to respond to your request by September 15, 1986.
