Complete construction:	June 1988

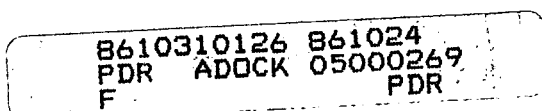
Please note that this schedule is contingent on the NRC response regarding the exception request which was submitted by letter dated June 18, 1986.
