

Dear Sir:

By letter dated May 5, 1987 the NRC Staff requested additional information regarding the protection of the emergency feedwater system (EFW) from the effects of high winds and tornado missiles, item II.E.1.1 of NUREG-0737. A response was requested within 45 days of receipt of the referenced letter.

Duke Power Company is currently in the process of preparation and internal review of the requested information. A response to your request is anticipated by July 17, 1987.
