

Dear Sir:

Mr. F. J. Miraglia's letter of July 9, 1987 transmitted Generic Letter 87-12. The Generic Letter requested a great deal of plant specific information as well as detailed discussions on numerous items. There have been extensive efforts on our part over the past few years to investigate the problems noted and we want to be sure that all of our findings and actions in this area are completely described. We are also attempting to provide a common format and a common level of detail between station responses. Organizing a great deal of written material from three different stations as well as from other Duke Power departments is taking more time than that given by this Generic Letter. We must also allow time for internal review of the responses before submittal.

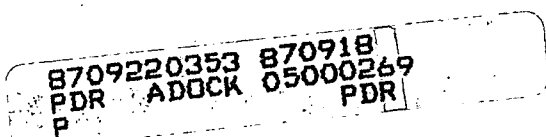
