

By letter dated March 1, 1985 Duke provided a copy of Revision 8 to the Oconee IST Program dated February 4, 1985. Revision 14 to the Oconee IST Program is currently in preparation and will be submitted as it becomes available.

Within Revision 13, the following additional requests for relief are included from the requirements of paragraph IWV of the 1980 Edition of the ASME Boiler and Pressure Vessel Code Section XI with Addenda through Winter 1980:
