

Dear Sir:

By letter dated October 11, 1985 the NRC issued its Safety Evaluation Report on Duke's response to Generic Letter 83-28, Item 3.2.2. The NRC found Duke's response acceptable and requested that Duke Power complete its actions in regard to this item and submit a statement confirming these actions have been completed.

By letter dated February 5, 1986 the NRC was informed that Duke anticipates to complete the review program concerning the vendor information and instruction manuals by the end of July, 1987. Duke is currently implementing a substantial review of the in-house copies of vendor manuals. However, due to the large volume of manuals and unavailable resources the completion of the review program has been delayed. Duke anticipates that the current review program will be completed by December 31, 1987.
