This letter refers to an investigation conducted by the U.S. Nuclear Regulatory Commission (NRC), Office of Investigations (OI) to determine if C&D Technologies (a) deliberately failed to enter deviations in their Part 21 process and make required notifications to the NRC in accordance with 10 CFR Part 21; (b) deliberately failed to prepare and submit an interim report for an identified deviation potentially associated with a significant safety hazard (SSH); (c) deliberately failed to evaluate deviations and comply with associated SSHs documented in 4 customer complaints (i.e., 2012-00163 at Clinton Nuclear Station; 2012-00007 at V.C. Summer Plant; 2013-00040 at Monticello Plant; and 2013-00113 at Salem Plant), and (d) deliberately provided incomplete and/or inaccurate information to customers in Certificates of Conformance 99901385/2014-201-02 and 99901385/2014-201-03. Based on the evidence developed during the OI investigation, the NRC could not substantiate that wrongdoing occurred. However, enforcement actions associated with the failures to comply with 10 CFR Part 21 identified above will be processed and tracked through the NRC's enforcement process.

Based on the evidence developed during the OI investigation, the NRC could not substantiate that wrongdoing occurred. However, enforcement actions associated with the failures to comply with 10 CFR Part 21 identified above will be processed and tracked through the NRC's enforcement process.
