Chairman Burns,

I believe there is a previously undescribed recurring geomagnetic risk to worldwide nuclear facilities. Intense magnetic disturbances, which may be predictable, could trigger serious accidents on either the electrical or nuclear side of these facilities.

2,000 geophysical events such as volcanoes, earthquakes and hurricanes have been correlated with astronomical configurations. Geometric or symmetric astronomical patterns have emerged associated with these events which include nuclear accidents.


The mechanism would simply be charged-particle spiraling around a disturbed intense magnetic field. The charged particle would be water with its partial-polar charge. A sudden compression/rarefaction of cooling water around the reactor core could be devastating.

Nuclear accidents studied include 1957 Chelyabinsk, 1961 Idaho Falls, 1979 3-Mile Island, 1986 Chernobyl, 1993 Toms-7, 1999 Tokai and 2015 Indian Point (Transformer Explosion).

Since the symmetric patterns are predictable, it is possible to generate high risk dates in advance. Here are some for the balance of 2015 - August 23, September 1, September 26, October 13, October 17, November 29 and December 23. Please understand there are high risk periods this Fall and Winter 2015 and Spring 2016. Please watch for other events as described above to occur on or around these dates.

It may be advisable to shut down nuclear facilities during certain periods to avoid extreme accidents.
