This letter acknowledges the letter from Mr. F. A. Kearney, Site Vice President, Byron Station, to the U.S. Nuclear Regulatory Commission (NRC), dated August 20, 2015, which provided a response to the Notice of Violation that was issued in NRC Inspection Report 05000454/2015008; 05000455/2015008, dated July 21, 2015.

We reviewed your response and find that it meets the requirements of 10 CFR 2.201, "Notice of Violation." In the August 20, 2015, letter, you identify the corrective actions that your facility has taken or plans to take to address the violation. The NRC has reviewed the corrective actions, which appear to be adequate, and has no further questions at this time. The actions that Byron Station has taken, and plans to take to address the violation, may be examined during a future inspection.

In accordance with Title 10 of the *Code of Federal Regulations* (10 CFR) 2.390, "Public Inspections, Exemptions, Requests for Withholding," of the NRC's "Rules of Practice," a copy of this letter will be available electronically for public inspection in the NRC's Public Document Room or from the Publicly Available Records (PARS) component of the NRC's Agencywide Documents Access and Management System (ADAMS).
