Dear Ms. Opila:

We have reviewed the proposed and revised final revisions to the Colorado Rules and Regulations Pertaining to Radiation Control, Parts 1, 3, and 18, and the revised final revisions to the legislation to amend the Colorado Radiation Control Act (Colorado House Bill 1145), received by our office on August 10, 2015. These were reviewed by comparison to the equivalent U.S. Nuclear Regulatory Commission (NRC) rules and the requirements of the four amendments and three provisions identified in the enclosed State Regulation Status (SRS) Data Sheet. In addition, the Colorado legislation (HB 1145) was reviewed by comparison to the Atomic Energy Act of 1954, Section 274; 10 CFR Part 40, "Domestic Licensing of Source Material"; 10 CFR Part 61, "Licensing Requirements for Land Disposal of Radioactive Waste"; and the Suggested State Legislation on "Radiation Control," published 1983 by the Council of State Governments. We discussed our review of the regulations and legislation with James Jarvis on September 29, 2015.

As a result of our review of the Colorado Rules and Regulations Pertaining to Radiation Control, we have five comments that have been identified in the enclosure. Please note that we have limited our review to regulations required for compatibility and/or health and safety. Under our current procedure, a finding that the Colorado regulations meet the compatibility and health and safety categories of the equivalent NRC regulation may only be made based on a review of the final Colorado regulations. However, we have determined that if your proposed regulations were adopted, incorporating our comments and without other significant change, they would meet the compatibility and health and safety categories established in the Office of Nuclear Material Safety and Safeguards (NMSS) Procedure SA-200, "Compatibility Categories and Health and Safety Identification for NRC Regulations and Other Program Elements."

We request that when the proposed regulations are adopted and published as final regulations, a copy of the "as published" regulations be provided to us for review. As requested in NMSS Procedure SA-201, "Review of State Regulatory Requirements," please highlight the final changes, and provide a copy to Division of Material Safety, State, Tribal, and Rulemaking Programs, NMSS.

In addition, as a result of our review of the Colorado legislation to amend the Colorado Radiation Control Act, it appears that you have addressed Comment No. 1 as stated in our letter dated February 18, 2015 (Agencywide Documents Access and Management System Accession No. ML15035A511); however Comment Nos. 2 and 3 stand as follows:

1. *“In Section 3 under 25-11-107 in the first paragraph, it states, “Prior to the application of any numeric groundwater standard different from the baseline standard contained in 10 CFR Part 40, the standard must have been approved by the United States Nuclear Regulatory Commission in accordance with Section 274o of the Federal “Atomic Energy Act of 1954”, 42 U.S.C. Sec. 2021(o).” The term baseline standard is not a 10 CFR Part 40 term. The statement needs to be changed to state, “Prior to the application of any numeric groundwater standard different from the basic ground-water protection standards imposed by the Environmental Protection Agency in 40 CFR Part 192, subparts D and E, the standard must have been approved by the United States Nuclear Regulatory Commission in accordance with Section 274o of the Federal “Atomic Energy Act of 1954”, 42 U.S.C. Sec. 2021(o).”*
2. *“In Section 1 under 25-11-101 under the definition for “BYPRODUCT MATERIAL”, it states in subsection 2, “Rules promulgated under this section must be consistent with United States Nuclear Regulatory Commission requirements necessary to maintain agreement state status and final regulations proposed by the Conference of Radiation Control Program Directors”. This needs to be changed to state, “Rules promulgated under this section must be consistent with NRC requirements necessary to maintain agreement state status and should be consistent with final regulations proposed by the Conference of Radiation Control Program Directors”.*

We recommend that you address the comments above concerning the authority provided to the Department under the 274b agreement with NRC. Colorado may resolve these comments through revision or interpretation of State law. Although the NRC will review all submittals to determine acceptability, NRC may accept interpretations provided by the State Attorney General, or other attorney designated as legal advisor to the radioactive materials program.

The SRS Data Sheet summarizes our knowledge of the status of other Colorado regulations, as indicated. Please let us know if you note any inaccuracies, or have any comments on the information contained in the SRS Data Sheet.
