The Nuclear Regulatory Commission recently published a Federal Register Notice announcing our intent to submit an information collection request to the Office of Management and Budget (OMB) for NRC Form 398, Personal Qualification Statement - Licensee. 4. How can the burden of the information collection be minimized, including the use of automated collection techniques or other forms of information technology?
