On August 19, 2015, the U.S. Nuclear Regulatory Commission (NRC) completed a security inspection at your Point Beach Nuclear Plant, Units 1 & 2. The NRC inspectors discussed results of this inspection with Mr. Brian Kopetsky, Security Manager and other members of your staff. Inspectors documented the results of this inspection in the enclosed inspection report.

The NRC inspectors did not identify any findings or violations of more than minor significance.
