
Pursuant to 10 CFR 50 §50.90, please find attached (Attachment 1) a proposed amendment to the Oconee Facility Operating License and revisions to the Oconee Nuclear Station Technical Specifications.

The requested revision to the Oconee Technical Specifications is in response to the NRC letter dated June 12, 1984 concerning Duke's response to Generic Letter 82-16 provided by a Duke letter dated December 28, 1982. The proposed revision to Specification 6.4.3 is in accordance with Generic Letter 82-16.

Please note that the added Technical Specification is a change that constitutes an additional limitation and control not presently included in technical specifications. Duke has determined that the proposed amendment warrants a No Significant Hazards Consideration. Please find attached (Attachment 2) the No Significant Hazards Consideration evaluation. A copy of this application is also forwarded to the South Carolina Department of Health and Environmental Control for review and, as appropriate, subsequent consultation with the staff.

Pursuant to 10 CFR 170, §170.12, please find enclosed a check in the amount of \$150 for the application fee.




