Pursuant to 10 CFR 50, §50.90, please find attached a proposed amendment to the Oconee Facility Operating License and a revision to the Oconee Nuclear Station Technical Specifications.

The proposed amendment request concerns Technical Specification 6.1.1.4 which is in the Administrative Controls Section (Attachment 1). The amendment will change the requirements for the Superintendent of Operations position so that the Superintendent holds or has held either an SRO License or SRO Certification. Presently an SRO License is required to be held or have been held for this position.

Attachment 2 provides the Technical Justification for the proposed amendment. In addition, as required by 10 CFR 50.91, Duke has performed a No Significant Hazards Consideration evaluation (Attachment 3) in accordance with the standards in 50.92. This analysis has determined that the proposed amendment request does not represent a significant hazards consideration.
