In Reference 1 and supplemented by letter on September 24, 2008, Ameren Missouri submitted an application for a combined license application (COLA) for Callaway Plant Unit 2. In Reference 2 the NRC documented acceptance of the COLA for docketing. In Reference 3 Ameren Missouri formally requested the NRC suspend review efforts associated with this COLA. In Reference 4 the NRC formally documented the suspension of COLA review as requested by Ameren Missouri with the acknowledgement that annual FSAR updates would still be necessary.

By this letter, Ameren Missouri hereby withdraws the COLA application for Callaway Plant Unit 2.
