Enclosed is Amendment No. 07 to your NRC Material License No. 24-32434-01 in accordance with your request. Please note that the major changes made to your license are printed in **bold** font.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

In correspondence dated June 19, 2015, and August 13, 2015, you requested the termination of NRC License No. 24-18627-01 for Southeast Health Center of Stoddard County, LLC, d/b/a SoutheastHEALTH Center of Stoddard County, 1200 N. One Mile Road, Dexter, Missouri, concurrent with the merger of the Dexter, Missouri facility's licensed program into your NRC License No. 24-32434-01.

These actions resulted from the change of ownership/control that occurred between your two licensed programs and was consented to by NRC, through a different materials reviewer, on April 16, 2013.

The termination of the Dexter, Missouri facility's NRC license has been completed and the termination documents are being transmitted under separate cover.

This letter confirms that the merger of the Dexter, Missouri facility's licensed program into your license is now completed.

The next, and final, step in these matters is the voiding of the renewal application for the Dexter, Missouri licensed program. "Void" means that we will take the renewal application out of our active pending casework database. In this instance, there will be nothing further that you will need to do to effect the void of the renewal, as the license has been terminated. We will be completing that action shortly. A letter documenting the voiding of the renewal application will be transmitted to you when that procedure is completed.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you.

This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions.

Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.
