Dear Mr. Beanblossom:

In correspondence dated June 19, 2015, and August 13, 2015, you requested the termination of NRC License No. 24-18627-01 for Southeast Health Center of Stoddard County, LLC, d/b/a SoutheastHEALTH Center of Stoddard County, 1200 N. One Mile Road, Dexter, Missouri, concurrent with the merger of the Dexter, Missouri facility's licensed program into your NRC License No. 24-32434-01.

These actions resulted from the change of ownership/control that occurred between your two licensed programs and was consented to by NRC, through a different materials reviewer, on April 16, 2013.

We recently sent you a letter confirming that the merger of your licensed facility's program in Dexter, Missouri program into the Poplar Bluff, Missouri license had been completed. NRC License No. 24-18627- 01 was terminated with Amendment No. 18.

The amendment documents reflecting said merger for License No. 24-32434-01 were transmitted under separate cover.

The final step in these matters is the voiding of the renewal application for your Dexter, Missouri NRC License. "Void" means that we will take the renewal application out of our active pending casework database.

Since your NRC License No. 24-18627-01 has been terminated, there is no longer a need to keep the renewal application for this license active.

Therefore, we have voided control number 588404 for the renewal of your now-terminated NRC License No. 24-18627-01.


