
Dear Ms. Burch:



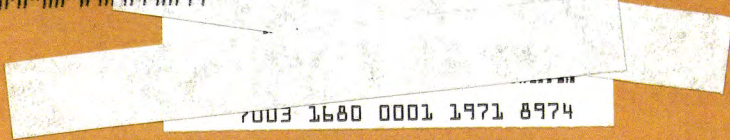
