In the Reference 1 letter, Exelon Generation submitted the License Renewal Application (LRA) for the LaSalle County Station, Units 1 and 2. In the Reference 2 letter, the NRC requested additional information to support the Staff's review of the LaSalle County Station Applicant's Environmental Report (Appendix E to the LRA). In the Reference 3 letter, Exelon Generation responded to the requests for additional information (RAIs) contained in the Reference 2 letter.

Enclosure A to the Reference 3 letter provided a cross reference index linking the Staff's RAIs (from the Reference 2 letter) with Index Item Numbers 001 through 058 assigned to the Exelon Generation responses, which were included in Enclosure C to the Reference 3 letter.


