Dear Dr. Bichay:

Enclosed is Amendment No. 88 to your NRC Material License No. 21-01078-01 in accordance with your request. Please note that the changes made to your license are printed in **bold** font.

We also made some minor updating and formatting changes to your license, which are also shown in **bold** font, especially the addition of ADAMS Accession Numbers in Condition No. 15.B of your license.

Please note that, at this time, we were unable to approve Jennifer Rollenhagen, M.D. as an authorized user (AU) for the use of materials in 10 CFR 35.100, 35.200 and 10 CFR 35.300, limited to the oral administration of iodine-131 because the information in your letter dated July 2, 2015, was insufficient to complete our review.

Dr. Rollenhagen was not approved as an authorized user (AU) for the use of materials in 10 CFR 35.100, 35.200 and the oral administration of iodine-131 because her application and supporting documents failed to include the signed preceptor statements required by 10 CFR 35.290(c)(2), 10 CFR 35.392 (c)(3) and 10 CFR 35.394 (c)(3).

Please submit the requested information by preparing a written response and transmittal business letter. When submitting your response, please mark it as "additional information to control number 588189" to my attention. This will help ensure that it is handled appropriately in our offices. Only one complete, currently dated and signed (by senior management) response is needed.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.


