SUBJECT: REQUEST FOR WITHDRAWAL OF COMBINED LICENSE APPLICATION FOR
CALLAWAY PLANT, UNIT 2 NUCLEAR POWER PLANT

Dear Mr. Bond:

By letter dated July 24, 2008, as supplemented by letters dated September 24, 2008, and November 14, 2008, AmerenUE (Ameren) submitted an application to the U.S. Nuclear Regulatory Commission (NRC) for a combined license (COL) for a single unit of the U.S. Evolutionary Power Reactor (U.S. EPR) in accordance with the requirements contained in Title 10 of the *Code of Federal Regulations* (10 CFR) Part 52, "Licenses, Certifications, and Approvals for Nuclear Power Plants." This reactor would be identified as Callaway Plant, Unit 2 and located at the current Callaway County, Missouri site of Callaway Power Plant (NRC License No. NPF-30). The COL application was accepted for docketing on December 12, 2008 (Docket Number 52-037) (Agencywide Documents Access and Management System (ADAMS) Accession No. ML083370485). By letter dated June 23, 2009, Ameren requested that the NRC staff suspend all activities relating to the COL application (ADAMS Accession No. ML091750988). By letter dated June 29, 2009, the NRC granted the suspension of the COL application (ADAMS Accession No. ML091750665). By letter dated August 12, 2015, Ameren requested that the Callaway Plant, Unit 2 COL application be withdrawn (ADAMS Accession No. ML15265A524). The purpose of this letter is to acknowledge your August 12, 2015, letter and to provide you with NRC's response.

In accordance with the requirements of 10 CFR Part 2, Section 2.107(a), and on the basis of the statements contained therein, your request to withdraw the Callaway Plant, Unit 2 COL application from the docket is acceptable to the NRC. Enclosed is a copy of the *Federal Register* notice announcing the withdrawal of the application from the docket, as required by 10 CFR 2.107(c). The staff communicated to you via a telephone call that the NRC staff would need to spend a few hours to administratively close out the application. You stated that Ameren agrees to pay for the accounted hours as long as the charges are reasonable.
