Title 10 Code of Federal Regulations Part 20.1501(c) requires that the licensee ensure that instruments and equipment used for quantitative radiation measurements be calibrated periodically for the radiation

License Condition 18.A states, in part, that the licensee shall conduct its program in accordance with the license application. Item 10: "Safe Use of Unsealed Licensed Material" of the license application dated April 18, 2013, states "the licensee will develop and implement written procedures for the safe use of unsealed byproduct material that meet the requirements of 10 CFR Part 20."

Contrary to the above, from July 29, 2002 through June 16, 2014, the licensee failed to develop and implement written procedures for the safe use of unsealed byproduct material that meet the requirements of Title 10 CFR 20.1501(c). Specifically, the licensee failed to ensure that a Sun Nuclear Corporation Model 1501 instrument, serial number 3165907, used at the Montana Heart Center to monitor for radioactive contamination was calibrated annually as recommended by the manufacturer.

The licensee removed the Sun wipe test counter from service on June 19, 2015. The licensee committed to updating Procedure DN1127 by August 20, 2015, and to create a new procedure for wipe tests of transport packages to monitor for radioactive contamination.

For the interim, the licensee will now analyze incoming package wipes and weekly area wipes using the approved procedures governing the Atom Lab 950 well counter, an appropriately calibrated instrument, located in the nuclear medicine department.
