Dear Mr. Lautenbach:

Enclosed is Amendment No. 09 renewing your NRC Material License No. 21-15281-02 in accordance with your request.

Your license has been renewed for a ten year term and will not expire until October 31, 2025.

For the sake of licensing economy, we decided to "void" (take out of our active database) your amendment request under control number 588496 and combine its review into your license renewal. This amendment resolves all changes requested and renews your license as well.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

We also made some minor updating and formatting changes to your license, which may also be shown in **bold** font, especially the addition of ADAMS Accession Numbers in Condition No. 20 of your license. Condition Nos. 10, 11 and 15 have been updated. Condition Nos. 17, 21 and 22, as they appeared on your Amendment No. 08, have been deleted at this time because they either no longer apply to your program or the requirements have been superseded by our regulations, especially 10 CFR 30.34 (i).

As a result of these changes, some of your Condition Nos. have been re-ordered. Please review them carefully and contact me if you have any questions.

In correspondence dated August 10, 2015, and August 12, 2015, you requested the release for unrestricted use of your former facility located at 4721 Runway Boulevard, Ann Arbor, Michigan.

The NRC staff has reviewed your final status surveys, which consisted of leak tests of the gauging devices you used and/or stored there.

Based on its review, the staff has concluded that all licensable radioactive material has been removed from your former facility and residual radioactive material attributable to licensed activities does not exceed current NRC criteria.

Based on these conclusions no further remediation or actions with respect to NRC regulated material is required for this facility and it is suitable for unrestricted use.

The enclosed document contains sensitive security-related information.
When separated from this cover letter this letter is uncontrolled.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you.

This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions.

Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.

The NRC's Safety Culture Policy Statement became effective in June 2011. While a policy statement and not a regulation, it sets forth the agency's *expectations* for individuals and organizations to establish and maintain a positive safety culture.


