Dear Dr. Jones:

Enclosed is Amendment No. 33 to your NRC Material License No. 24-17205-01 in accordance with your request. Please note that the changes made to your license are printed in **bold** font, including the addition of ADAMS accession numbers to Condition No. 14.B.

At this time we also deleted David S. Goodin, Ph.D. as an Authorized Medical Physicist (AMP) from your license because your license does not authorize any materials that require an AMP.

This also refers to the telephone discussion on October 19, 2015, between me and your proposed, now approved, Authorized User (AU), Cherie Jean Hayostek, M.D. In this discussion, Dr. Hayostek advised me that B. Michael Driver, M.D. was no longer working for your facility.

However, in my review, I noted that we have not received a notification from you directing us to delete Dr. Driver from your NRC license, as required by 10 CFR 35.14(b)(1).

We have not deleted Dr. Driver from your license in this amendment because we have not been directed to do so in writing and under an appropriate signatory, pursuant to 10 CFR 35.12(a), i.e., a senior management representative.

Please make this required notification to us in a subsequent amendment request to comply with 10 CFR 35.14(b)(1).

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you.

This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions.

Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.


