This letter is to express our gratitude and thanks to Pacific Gas and Electric Company (PGE) for hosting the International Atomic Energy Agency (IAEA) Research Reactor Decommissioning Demonstration (R2D2) Project Workshop on “Release of Building and Sites/Final Survey” at the Humboldt Bay Nuclear Power Plant Decommissioning Project September 28–October 2, 2015.
