Dear Mr. Brown:

This refers to your license amendment request dated September 11, 2015. Enclosed with this letter is the amended license. The amended license authorizes you to acquire Humboldt Scientific, Inc., Model 5001 gauge(s), however, the maximum possession limits previously authorized on the license remain unchanged.

Please note that the amended license does not include the additional storage location at 55 Leroy Road, Williston, VT that you had requested in your letter because this location is already authorized on another NRC License No. 44-35214-01. NRC policy does not permit authorization of one storage location on two different licenses. You may request another amendment to your license to include this location after the location is removed from license No. 44-35214-01.

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region I Office, Licensing Assistance Team, (610) 337-5239, so that we can provide appropriate corrections and answers.

An environmental assessment for this action is not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
