On March 19, 2015, PPL Susquehanna, LLC submitted a license amendment request (Reference 1) to revise the Emergency Action Level (EAL) scheme for the Susquehanna Steam Electric Station Unit 1 and 2 (SSES) Emergency Plan. The revised EAL scheme was based on Nuclear Energy Institute 99-01, Revision 6, "Development of Emergency Action Levels for Non-Passive Reactors."

On August 25, 2015, a conference call was held between the Nuclear Regulatory Commission (NRC) and Susquehanna Nuclear, LLC staff to discuss the draft NRC request for additional information (RAI) and our proposed response to the RAIs. Susquehanna Nuclear, LLC subsequently received the final RAIs on August 26, 2015 (Reference 2). The purpose of this letter is to provide Susquehanna Nuclear, LLC's response to the RAIs.

Enclosure 1 provides Susquehanna Nuclear, LLC's response to the NRC's request for additional information. Enclosure 2 provides a marked up copy of SSES's EAL Basis document, which incorporates the RAI responses from Enclosure 1. Enclosure 3 provides a clean copy of the SSES EAL Basis document with the RAI responses incorporated.


