Ms. White,

This email is in follow-up to our telephone conversation this morning concerning your amendment request to add Mr. Gravning and Jennings to your license as non-medical authorized users. Although both individuals have the experience in performing instrument calibrations, the training that was submitted is not specific to instrument calibrations. During our conversation, you indicated that you would withdraw this request and resubmit your once both individuals have received specific training. Until that time, you will send your survey instruments to Cardinal Health for calibrations.

We also discussed the fact that Item 9.D. on your license gives you the authority to calibrate survey instruments and personnel dosimeters for NRC License Number 40-32477-01 only. If you wish to perform this service for other licensees (NRC and/or Agreement State), you will have to submit an amendment request, along with the additional supporting documentation. For guidance, you may use NUREG 1556, Volume 18. For your convenience, I have included a link to this document. Please be advise that adding the authorization of a service provider to your license will result in additional fees. Please contact Jawanza Gibbs-Nelson to discuss the additional fee amount. Her number is 240-718-8670. Her email address is Jawanza.Gibbs-Nicholson@nrc.gov.

I will issue a partial amendment request. I will remove the authorized users from your license that you request and I will amend Item 9.D. on your license to read "possession only." This means that until you resubmit your request to add the non-medical authorized users to your license, and receive approval from the NRC, you cannot use the sealed source listed in Item 6.D., 7.D., and 8.D.
