The Texas Radiation Control Program is pleased to present the attached proposed rules for NRC's review. Recognizing NRC's Agreement State compatibility date of March 19, 2016, Texas is submitting these proposed rules for NRC's review to complete the review process as soon as possible. Revisions to the Texas Regulations for Control of Radiation, Title 25, Texas Administrative Code (TAC), include the following sections:

§289.201 relating to General Provisions for Radioactive Material

§289.202 relating to Standards for Protection Against Radiation from Radioactive Materials

§289.251 relating to Exemptions, General Licenses, and General License Acknowledgements

§289.252 relating to Licensing of Radioactive Material

§289.257 relating to Packaging and Transportation of Radioactive Material

The proposed revisions for §§289.201, 289.202, 289.251, 289.252, and 289.257 were presented to the Texas State Health Services Council (SHSC) on September 9, 2015. On September 10, 2015, the SHSC provided their consent to allow the Health and Human Services Commission (HHSC) review of these proposed rules to proceed. That review is still in progress.

Following final approval by the Executive Commission of HHSC, the proposed rules will be published in the *Texas Register* and made available via our website email system for a 30-day public comment period. Since these proposed rule requirements are essentially identical to the NRC's 10 CFR, Part 37, rule requirements, no significant changes are expected. If any significant changes are identified, we will notify the NRC immediately.

The proposed regulations are identified by underlined text for new text and **[bold face and brackets]** for deleted text. Please see the following chart that identifies the outstanding required changes in order for Texas to meet NRC compatibility
