SUBJECT: WITHHOLDING PROPRIETARY INFORMATION FROM PUBLIC
DISCLOSURE - SUBMITTAL OF HUMAN FACTORS ENGINEERING
PROJECT MANAGEMENT PLAN (PROJECT0769)

Dear Mr. Bergman:

In an October 5, 2015, letter (Agencywide Documents Access and Management System (ADAMS) Accession No. ML15279A168), Mr. John Price, Licensing Director, DCA Production, requested that the following human factors engineering project management plan be withheld from public disclosure pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR), Part 2, Section 2.390:

- NuScale Power, LLC – Enclosure 2, “Human Factors Engineering Program Management Plan,” RP-0914-8534-P, Revision 1, (Proprietary) ADAMS Accession No. ML15279A169

A nonproprietary copy of the project management plan have been placed in the U.S. Nuclear Regulatory Commission (NRC) Public Document Room and added to ADAMS at the following accession number:

- NuScale Power, LLC – Enclosure 1, “Human Factors Engineering Program Management Plan,” RP-0914-8534-NP, Revision 1, (Non-Proprietary) ADAMS Accession No. ML15279A168

The affidavit in the October 5, 2015, letter stated that the submitted information should be considered exempt from mandatory public disclosure due to the proprietary nature of the information that will be presented and discussed.

The NRC staff has reviewed your application and the material in accordance with the requirements of 10 CFR 2.390 and, on the basis of the statements in the affidavit, have determined that the submitted information sought to be withheld contains proprietary commercial information and should be withheld from public disclosure. Therefore, the version of the submitted information marked as proprietary will be withheld from public disclosure pursuant to 10 CFR 2.390(b)(5) and Section 103(b) of the Atomic Energy Act of 1954, as amended.

Withholding from public inspection shall not affect the right, if any, of persons properly and directly concerned to inspect the documents. If the need arises, the NRC staff may send copies of this information to our consultants working in this area. The NRC staff will, of course, ensure that the consultants have signed the appropriate agreements for handling proprietary information.
