SUMMARY AND ACTION REQUIRED (IF ANY)

In a 10/15/15 e-mail I had forwarded to Mike, the licensee's 10/1/15 response to my RAI. The RAI was documented in a 9/23/15 conversation record. The RAI was submitted to the licensee based on Mike's review of the licensee's request to release a waste storage room for unrestricted use. The room was used to store both short and long lived (unsealed) radionuclides.

Mike reviewed the licensee's 10/1/15 response and sent me an e-mail dated 10/16/15. Mike clarified his 10/16 e-mail to me by stating that the licensee's 10/1 response was adequate, and that no additional information was needed.

Mike agreed that the waste storage room could be released for unrestricted use.

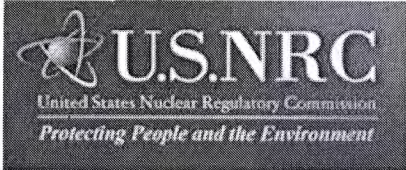

We normally ask for survey records to verify instrument eff., residual radiological contamination (if any), type of nuclides tested against, and where the surveys were taken. I took a brief look at the licensee history and it

looks like no significant long-lived nuclides are a concern here (H-3 and C-14 in those quantities are not usually a significant concern). Otherwise, looks good.
