Dear Mr. Hanson:

The Region I Field Office, NRC Office of Investigations (OI), initiated an investigation (Case No. 1-2014-027) on August 26, 2014, to determine whether an Administrative Coordinator in the Maintenance Planning Group at Peach Bottom Atomic Power Station was subjected to discrimination for raising safety concerns. Based upon documentary and testimonial evidence developed during the OI investigation, there was insufficient evidence developed for the NRC to substantiate that the individual was discriminated against for raising safety concerns.

Please note that final NRC investigation documents, such as the OI report described above, may be made available to the public under the Freedom of Information Act (FOIA) subject to redaction of information appropriate under the FOIA. Requests under the FOIA should be made in accordance with 10 CFR 9.23, Requests for Records. Please be aware that a FOIA will not be honored until the subject allegation file is closed.

Also, in accordance with 10 CFR 2.390 of the NRC's "Rules of Practice," a copy of this letter will be available electronically for public inspection in the NRC Public Document Room or from the Publicly Available Records (PARS) component of NRC's document system (ADAMS).
